Rex Cowdry

Rex Cowdry and Donna Patterson retired, sold their DC house, and now live full time in the East Beach home they built in 1997. Trained as a doctor, Rex developed research, administrative, and budgetary skills at the National Institutes of Health where he ran the Neuropsychiatric Research Hospital, chaired the Medical Board of the Clinical Center, and headed the National Institute of Mental Health. He has also served as Executive Director of the Maryland Health Care Commission, developing state health care policy and advising on health care legislation, and as Associate Director of the White House National Economic Council, where he worked on health information technology, health savings accounts, and health care reform.
